Interested bidders may purchase a complete set of Bidding Documents in English language from the **Procurement Branch, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte (Tele- +94112390719, Fax- +94112390720, E-Mail (procurement@defence.lk)** on the submission of a written application to the **Chief Financial Officer I, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte** from dates mentioned in para 1, **between 0900 hrs to 1500 hrs** on every working day with effect from **23rd September 2024** after paying the Non-refundable fee indicated against the procurement mentioned at para 1 above to the Secretary, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte and the Bidding Document can be inspected (Free of charge) at Procurement Branch, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte from **0900 hrs to 1500 hrs**. The method of payment of the non-refundable deposit will be in cash. The Bid shall be **valid up to 04th February 2025**.

Completed bid proposal must be couriered/ delivered to the address below, marked with Tender Identification Number on or before the stipulated time and date mentioned in above para 1 and late bids will be rejected. Bids will be opened immediately after the closing of the bids in the presence of the bidders/ bidders' representatives who choose to attend the Bid Opening, in person at the address below as per the referred time and dates mentioned above. No bidder or his representative will be permitted to attend the bid opening after the bid closing time.
