The Chairman, High Level Procurement Committee (HLPC) on behalf of the CEYLON ELECTRICITY BOARD hereby invites sealed bids from eligible and qualified Bidders for the Procurement of Lot A-Construction of Mullikulam 220kV Metering Substation and Augmentation of Mannar 220/33kV Grid Substation, as described below.

2. Time for completion of the Works in 18 months.

3. Bidding will be conducted through the International Competitive Bidding (ICB) Procedure.

4. To be eligible for contract award, the successful Bidder shall not have been blacklisted and shall meet the following requirements;

For local bidders;

Specialty : Building Construction or Highway Construction and Electrical and Mechanical Services

Grade : C2 and above and EM1

Expiry date : The CIDA registration shall be valid for at least up to three months from the bid closing date.

For Foreign bidders; When notified must obtain CIDA Registration before the Award of Contract, the registration fee shall be 0.01% of the contract sum

5. Qualification requirements to qualify for contract award include:

- Participation as a contractor, Joint Venture partner, or Subcontractor, in at least **two** contracts that have been satisfactorily and substantially completed within the last **ten (10)** years and that are similar to the proposed contract, where the value of the Bidder's participation under each contract exceeds **USD 6 million**. The similarity of the Bidder's participation shall be based on a, b the physical size, nature of works, complexity, methods, technology, or other characteristics as described in Section 6 (Employer's Requirements) of the bidding document.
- Minimum average annual turnover(should be verified in the audited accounts) of **USD 10 million** calculated as total certified payments received for contracts in progress or completed, within the last **three (03)** years.
- The Bidder must demonstrate that its financial resources defined in form FIN - 3 in the bidding document, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of **USD 1.6 million**
- Please refer to the bidding document for further Qualification and Eligibility criteria.

Technical Bids will be publicly opened soon after closing in the presence of the Bidders' designated representatives at the office of Office of Additional General Manager (Projects), Ceylon Electricity Board, 385, 4th Floor, Landmark Building, Galle Road, Colombo 00300, Sri Lanka, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the Contract is awarded.
 - Late Bids shall be rejected
9. Bids shall be valid for up to **180 days**.
10. All bids shall be accompanied by a Bid-Security of **LKR 22 million** or **US\$ 75,000**. Bid Security shall be valid up to a minimum of **28 days** beyond the validity of Bid.
11. A Pre-Bid meeting will be held on December 11, 2025 at 10:00 hours at the office of the Deputy General Manager (Transmission Projects), Ceylon Electricity Board, 1st Floor, GOBA Building, No.65/1, Sir Chittampalam A. Gardiner Mawatha, Colombo 02, Sri Lanka. A site visit conducted by the Employer will be organized on the following day of the pre-bid meeting, starting at 10:00 hrs. The route plan and the time schedule for the visit will be informed during the pre-bid meeting. Bidders will have to arrange their own transport and other facilities. Participation to pre bid meeting and site visit is mandatory.
12. When comparing Bids, the Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.
13. The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation, attending Pre-Bid meeting, site visits and delivery of Bids.
